This Agreement is effective of 10th January 2019.

Items Purchased

Design of machine

2.1.1 These models is only to be supplied to GALEA in Ankara city.

This must not be sold to any persons, business / companies or manufacturers in Ankara, Turkey.

If the Purchaser can no longer make the minimum order requirements the supplier will have the right to amend this agreement and supply to Ankara, Turkey. The supplier must still abide by all other terms of this agreement.



Design of software and its content

3.1.1 The content of the custom designed screen images supplied to the supplier by the purchaser are confidential and will not be used on any other machines or digital/print content. This includes but not limited to, photos, logos and wording.

3.1.2 The content of the custom designed screen images and logos must not be shared with any other persons, business/companies or manufacturers.

Quality of Goods

4.1.1 The quality of the machine and all parts must arrive as described when placing purchase order, all in working order with no damage or faults.

4.1.2 If the machine is to arrive to the purchaser damaged or faulty, the supplier will replace in a timely manner. Return of damaged or Faulty machines is at the cost of the supplier.

Warranty

5.1.1 Each individual machine is supplied with a 12month warranty by the supplier to the purchaser. This covers any software faults or faulty parts, and all spare parts.

5.1.2 If the machine or any parts are faulty the supplier will cover the cost of postage and repairs. Or replace with new machines/parts.

5.1.3 Any damage to the machine or any of the associating parts caused by misuse or accidental impact will be at the cost of the purchaser.

Payment

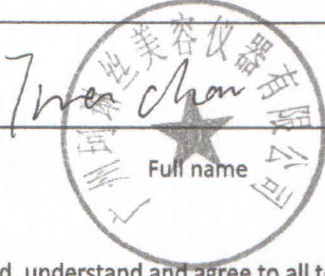
6.1.1 Payment shall be made to the Supplier before goods will be shipped.

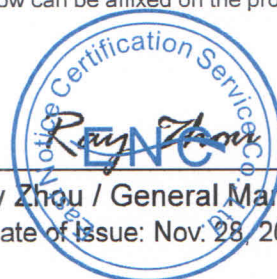
